CONDITIONS OF SALE

PLEASE READ CAREFULLY

All bookings made with Himalayan Frontiers, named in that by "Agency" shall be subject to the following conditions:

BEFORE DEPARTURE:

1. The person who signs the booking form accepts these conditions and will be referred in what follows by "customer".
2. Booking: For booking a tour is firm, the customer must complete and sign the booking form, and mail to the address of the agency with a deposit of \$ 200 or € 200 per person. Customers will be informed in writing of the booking confirmation. The balance must be paid 60 days before departure or 60 days before the date of commencement of supply of the agency.
3. Cancellation: All cancellations must be made in writing and signed by the person who signed the booking form and will be taken into account to the agency upon receipt of that letter.
4. If you wish to cancel, you will be withheld from us for a cancellation occurs:
 - * 60 days or more before departure: 10% of the trip.
 - * Between 59 days and 29 days before departure: 30% of the cost of travel
 - * Between 28 days and 15 days before departure: 60% of the cost of travel
 - * Less than 15 days before departure: 100% of the trip.It is strongly advised to take a cancellation insurance.

ONSITE

1. The agency can not be held responsible for bad weather, flight cancellations, threats of war and civil war, strikes, demonstrations, incidents of political or any other exceptional case of force majeure and unpredictable. The Agency reserves the right to modify the circuit, to use other means of transport in case of breakdown, illness or any other event of force majeure. All extra expenses such

- as hotel nights, flights or additional transport costs will be borne by the customer and resolved on the spot.
2. Travel Insurance: The customer is invited to bring before departure, an insurance covering loss of baggage, medical expenses and, where applicable, repatriation, rescue helicopter, accidents, death, annulment or reducing number of days in the circuit.
 3. Passport, visa and vaccination: The customer must have a valid passport and must obtain any visas, permits and vaccination certificates required by the circuit.
 4. The Agency reserves the right to change the itinerary, details of services, vehicle or mode of transport when it deems necessary or reasonable to protect the safety of the client.
 5. No refunds will be made for any service rendered not for the reasons cited above and to any customer leaving the circuit en route en route or wish to change him circuit.
